Frontier Fire Hall is located roughly midway between Buffalo, New York, and Niagara Falls, New York. Also close to the Canadian border, the show will attract Canadian as well as Western New York avid antique and fine collectible enthusiasts. Public admission will be \$3 for two days.

Set-up time: 2 PM to 7 PM Friday February 23rd **(EXHIBITORS ONLY)**

Show hours: 9 AM to 4 PM Saturday February 24th, and 10 AM to 4 PM Sunday, February 25th.

(NO PACKING UP BEFORE 4 PM ON SUNDAY. BUILDING MUST BE VACATED BY 7 PM ON SUNDAY)

BOOTH RATES 10' BY 10' booth (includes (3) tables) \$50.00

Discounted booth rate of \$40.00 if paid before February 10, 2018

Additional booths may be purchased at the \$50.00 inc. (3) tables. Electricity available, Space limited.

First come, first served. Free coffee and donuts Saturday & Sunday morning for dealers only.

Exhibitors must agree to the terms and conditions of this contract.

1. No crafts or food shall be offered for sale. All items presented shall be antiques or high quality collectibles, in keeping with the spirit of the show in providing fine quality antiques and collectibles to the public, and shall be guaranteed as represented. Show chairman shall have final approval authority over items offered for sale. All items shall be truthfully represented. All items shall be priced.
2. No smoking shall be permitted in show premises. No improper behavior shall be permitted.
3. No hazardous/offensive exhibits or conditions shall be permitted.
4. Exhibitors shall be open for business on time and shall not repack until the show closes. All exhibitors shall abide by all municipal, state, and federal laws including New York Sales Tax laws. **Exhibitors must have valid NY State Tax ID number**
5. Overnight security shall be provided.
6. Exhibitor spaces shall be properly maintained – table shall be covered to the floor; boxes shall be kept under the tables; floor and aisles shall be kept clear and free of trash.

Exhibitor spaces shall be cleaned up at the end of the show. Any damages to premises, tables, or chairs shall be paid for by exhibitor.

7. No subletting without prior permission. Only one adult helper per individual exhibitor unless prior permission is granted.

8. Neither the Niagara County Central Rotary Club nor the Frontier Fire Hall, nor their agents, officers, or employees shall be held liable for any property damage or loss or personal injury to any exhibitor, its agents, or employees. Exhibitor accepts full responsibility and releases Niagara County Central Rotary Club and Frontier Fire Hall and their agents, officers, and employees from all liability and any losses, damage, or injuries which may occur to any Exhibitor, its agents, its employees, or its personal property.

9. Any Exhibitor or assistants violating show rules may be asked to leave without a refund or other recourse.

10. The price of each booth is \$50.00 and includes three tables. **Exhibitors do not have to use all three tables.** Please include the number of tables you plan to use in each spot that you purchase.
